❑ **\$146 BILLION 10-YEAR PLAN APPROVED** - The 2026 Unified Transportation Program (UTP) process is now complete and the total funding allocated to planning, building and preserving the state highway system continues to grow. The statewide funding distribution chart is on Page 2. The total includes \$101 billion for project construction, \$34 billion for planning, engineering and right-of-way, plus \$11 billion for important routine system preservation. The plan includes 27 projects on the I-69 System that are now programmed to go to contract in the next four years. That includes \$2.6 billion for three projects in Houston and \$2.3 billion for projects elsewhere. The biggest of these are the upcoming Marshall Relief Route, Nacogdoches freeway upgrades, extension of I-69 in San Jacinto County, Sinton Relief Route, widening of US 59 in Bee and Live Oak Counties, and five incremental projects on US 281 in Hidalgo, Brooks and Jim Wells Counties.

❑ **OCTOBER DC FLY-IN** - October 21st will be Future Interstates Advocacy Day in Washington, DC, with participants expected from Texas and a number of other states. The I-69 Alliance has joined with the I-14 Coalition, the I-27 Ports-to-Plains Alliance and the I-73 Alliance in urging Congress to include new funding for multi-state Future Interstate Highways in the next surface transportation authorization bill. The current bill expires in September 2026, so congressional committees are in the process now of developing the next bill. The Future Interstates delegation will meet with members and staff on Capitol Hill and with representatives of the Administration. Email



A new dedicated funding mechanism is essential to completing vital interstate corridors across the nation. We are encouraging Congress to act with the same federal funding boldness that built the Interstate System 70 years ago.

❑ **MORE I-69 COMING** - The Transportation Commission is expected to give final approval on Sept. 25 to officially adding several miles of US 59 in Liberty County to the Interstate Highway System. That means we will see more I-69 signs going up soon. 220 miles of the I-69 System in Texas are now interstate and more miles are complete and open to traffic but await federal approval.

❑ **NEW BOARD MEMBER** - Scott Norton, representing the Texarkana Chamber of Commerce, is the newest member of the I-69 Alliance Board of Directors. Scott is executive director and CEO of TexAmericas Center, a 12,000 acre mixed-use industrial park on the site of a former DOD facility near the north end of the I-69 System in Texas.

❑ **REDISTRICTING ON I-69 CORRIDOR** - The Texas Legislature closed shop last week after passing a bundle of bills including a new congressional redistricting map. If that map is not set aside by a court challenge it will bring changes to the representation of sections of the I-69 Corridor. Nacogdoches County moves to District 1, now held by Rep. Nathaniel Moran. Angelina County has been added to District 36 held by Rep. Brian Babin. Polk and San Jacinto Counties move to District 10, now held by Rep. Michael McCaul. In South Texas, most of Nueces County and Corpus Christi have been moved into District 34, held by Rep. Vincente Gonzalez.



❑ **APPOINTMENTS** - The Transportation Commission has appointed Michael Medina, executive director of the Rio Grande Valley MPO, to the Border Trade Advisory Committee. Members reappointed in August include Cynthia Garza-Reyes, Pharr assistant city manager; Marga Lopez, Progreso International Bridge; and Juan Olaguibel, Anzalduas Port of Entry. The Commission has reappointed four members of the Port Authority Advisory Committee including Sean Stibich, Port of Victoria; Phyllis Saathoff, Port Freeport; Walker Smith, Port of Harlingen; and Chris Fisher, Port of Beaumont.




